The Commander shall appoint all Appointed Officers and Committee Chairpersons necessary to carry out the programs of The American Legion. The Commander shall attend all Department Executive Committee Meetings, Department Conferences and Department Conventions.

Senior Vice-Commander: It shall be the duty of the Senior Vice Commander to be prepared to perform the duties of the Commander when called upon and shall succeed the Commander in case of death, resignation or removal. The Senior Vice Commander shall be the district membership Chairperson and serve on the Department of Missouri Membership Commission.

Vice-Commander at Large: It

shall be the duty of the Vice Commander at Large to assure the several Committee Chairs carry out the programs of The American Legion. The Vice Commander at Large shall be responsible for assuring the Committee Chairs submit candidates for Boys State, Cadet Patrol and other Ameri-

can Legion programs in a timely manner to Jack Rennaker assure acceptance of such candidates by the Department of Missouri.

Adjutant: It shall be the duty of the Adjutant to keep a correct record of all proceedings of District Meetings and Executive Committee Meetings. Revised December 9, 2017 The Adjutant/Finance Officer shall receive all money belonging to the District and account for the same. The Adjutant/Finance Officer shall pay all bills ordered by the District Membership or Executive Committee. The Adjutant/ Finance Officer shall keep account of his or her receipts and expenditures and give or send reports of same to the District meetings or on demand of the Commander or the Executive Committee. The Adjutant/ Finance Officer shall turn over to his or her successor all money, vouchers, books and papers belonging to the District. The Adjutant/Finance Officer shall chair a committee to prepare an annual District Budget.

District Service Officer:

It shall be the responsibility of the District Service Officer: to advise and assist Post Service Officers as required. The Service Officer shall be familiar with laws and practices under which veterans benefits are obtained and advise Post Service Officers of such as required from time to time.

Chaplain: It shall be the duty of the Chaplain to offer prayer at the opening and closing of District Meetings and such other duties as may be prescribed by the Commander including; but limited to Memorial Services and Dedications.



Judge Advocate: The Judge Advocate is the District Parliamentarian. The Judge Advocate shall be familiar with Robert's Rules of Order, Newly Revised and constitutional form of rules under which the District operates. The Judge Advocate shall advise the District Commander of all matters of parliamentary procedures.

Sergeant-At-Arms: It shall be the duty of the Sergeant-at-Arms to retain possession of the District Banner and to post it and the Colors of the United States at each District Meeting. The Sergeant-at-Arms shall serve as the official greeter on behalf of the Commander at District Meetings and shall inform the Commander of all distinguished visitors present at District meetings. The Sergeant-at-Arms and/or any Assistant Sergeants-at-Arms appointed by the Commander is responsible for seeing that each member attending a District Meeting has copies of the meeting agenda and other pertinent documents.

He then sat out a year for Alex Slocum to take over, but was reelected by a motion from our district at the Department Convention in Cape Since taking office in June, I've been Girardeau. He will now serve our 2026 year as Vice Commander for Zone 3. If you get a chance some time, please thank Mark for his service to The American Legion.

> Our membership for the past year was not the best, but we finally pulled out a pretty good finish. We finished 2025 with 1,557 members which placed us at number 10 out of 16 posts for an average of 90.57% as a percentage of goal for the year. Some of you might not be aware that 17th District ranks #5 for district size with 1,557 members. Hopefully we will meet our goals for the coming year since they have become more aware of the difficulty in setting goals that are almost impossible to achieve (Thank you to Alex Slocum who is now the Vice Commander for the Department of Missouri) for setting goals at 1 new member for each post. So now we need to replace about 7% of the members we might loose from death, old age, moving from state, etc. and then the new at the district level plus 16 new members. EDITORIAL OPINION

This will be the Editorial Opinion about what ever the editor decides to write about. It will be a discussion about items of potential concerns of veterans about things happening in the world.

Let's talk about "The Rule of Law" as in "No one is above The Rule of Law" even the President. We hear this quite often on newscaster's and politician's speeches. Well for me and most veterans that rule is The Constitution of the United States. Before any political discussions I generally try to make sure we all agree about this rule. First lets see what The American Legion feels about it. (taken from their website).

The American Legion believes national security must be maintained to fulfill the mandate for a strong national defense. As stated in the Preamble, "FOR GOD AND COUNTRY WE ASSOCIATE OURSELVES TOGETHER FOR THE FOLLOWING PURPOSES: To uphold and defend the Constitution of the United States of America... To safeguard and transmit to posterity the principles of justice, freedom and democracy."

The Legion is an organization of veterans who fought for freedoms, which they are dedicated to keeping and preserving. As one of the Four Pillars it was founded on, the Legion believes national security is upheld by keeping a well-funded Department of Defense, a good quality of life for troops and a sensible transition between service and separation.

If we consider the importance of this statement from The American Legion, then we must see it is the second most important pillar of the legion. It falls just after just after Veteran Affairs and Rehabilitation as the first pillar. It then lists it as National Security. Which is quoted below:

Every member of The American Legion has sworn an oath to protect and defend this country against all enemies, foreign or domestic. The events of Sept. 11, 2001 has shown that at no time should National Security not be foremost in everyone's mind. Legionnaires are vigilant in their scrutiny of legislation at all levels of government to ensure this nation's security is always protected.

As mentioned above we all swear an oath to the Constitution. As all military and elected officials swear the same oath before they serve the US. This will differ in small details depending on the specific branch or position involved, but it appears below taken from the oath of the Vice President of the US.

"I do solemnly swear that I will support and defend the Constitution of the United States against all enemies, foreign and domestic, that I will bear true faith and allegiance to the same: that I take this obligation freely, without any mental reservation or purpose of evasion, and I will well and faithfully discharge the duties of the office on which I am about to enter. So help me God."

This oath that everyone that wins election to congress must quote comes from precedents started in 1884 and continues until today. If we don't abide by our oath then we may end up with Anarchy in which no sane person would every want for our country.

Political Violence:

In recent times we have had political violence with the last being Charlie Kirk (a conservative Christian activist) and before that Minnesota elected state officials Melissa Hortman and her husband were murdered in their home (they were democrats).
